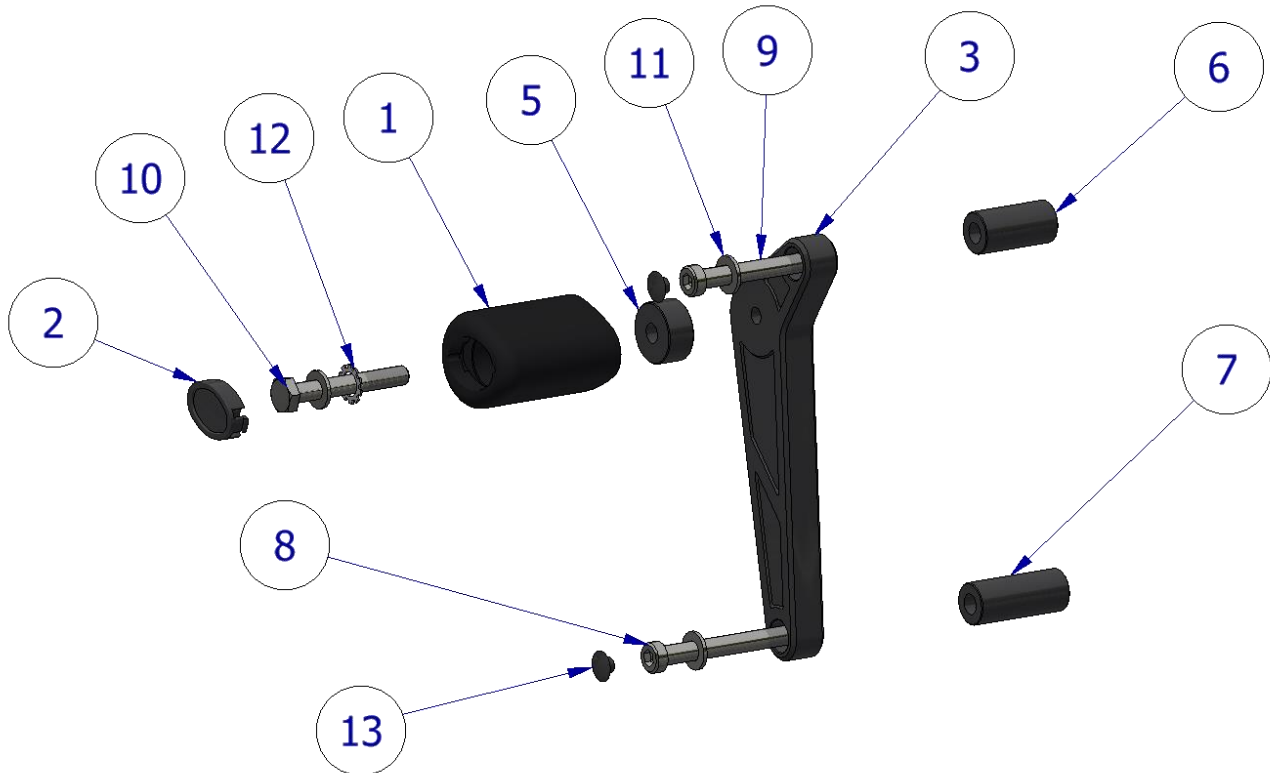

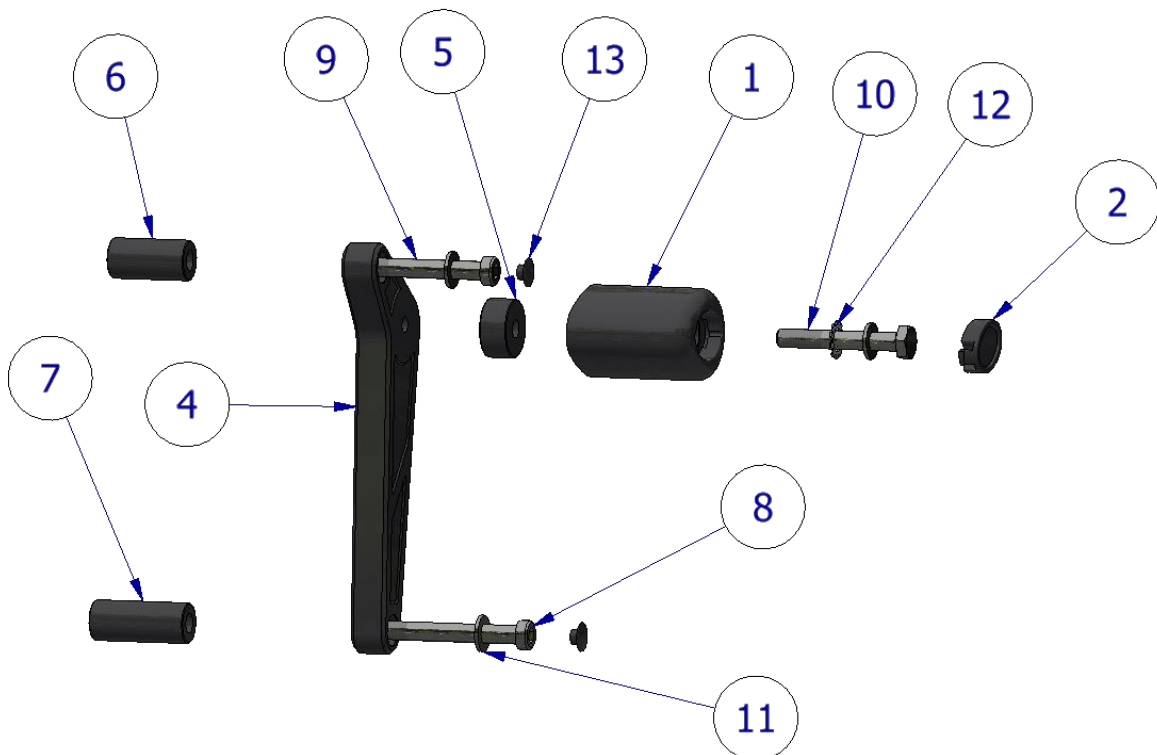


EXPLODED ASSEMBLY VIEW

FITTING PICTURE



FITTING INSTRUCTIONS

Before removing engine bolts, ensure the bike is upright and supported by a suitable engine stand or jack placed under the sump of the motorbike to support the partial weight of the engine, this will prevent the engine from moving during fitting. DO NOT REMOVE MORE THAN 1 ENGINE BOLT AT ANY TIME.

- 1.** Assemble the crash protector kit (**Items 1 & 3-12**) as shown in the **EXPLODED ASSEMBLY VIEW** for both RHS & LHS.
- 2.** Remove the bottom bolt circled in the **Fitting Picture** (this is the same on both sides of the bike) and thread the bottom bolt (**Item 8**) of the corresponding side through the frame into the engine approx. 80% of the way (do not fully tighten).
- 3.** Now remove the top bolt circled in the Fitting Picture and thread the M10 x 80mm bolt (**Item 9**) through the frame and into the engine.
- 4.** Finally tighten the M10 x 70mm bolt (**Item 10**) until you feel some compression. Using our GENERAL TORQUE SETTINGS on PAGE 2 tighten all bolts to the correct torque. **PLEASE NOTE THE CRASH PROTECTOR MUST BE POSITIONED AS SHOWN IN THE PICTURES WITH BIGGER END TOWARD FRONT OF BIKE.**
- 5.** If not already fitted, fit bubble sticker into recess of bobbin cap (**ITEM 21**).
- 6.** Fit crash protector cap (**ITEM 2**) into the crash protector (**ITEM 1**), and nut caps (**Item 13**) into the exposed caps of the bolts (**items 8 & 9**).

REPEAT THE ABOVE STEPS FOR BOTH SIDES OF THE MOTORCYCLE.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
