

FITTING INSTRUCTIONS

- Remove the 2 OEM bolts in the locations circled in the picture above.
- Insert the comp sleeves (Items 2 & 3) into the slider (Item 1) as shown in the assembly diagram.
- Thread the bolts (Items 4 & 5) through the washers (Item 6) and slider (Item 1) in the orientation shown in the exploded assembly view.
- Offer the assembly up to the bike as shown in the fitting picture above and tighten the bolts fully.
- Fit the bubble sticker as shown in the fitting picture.


